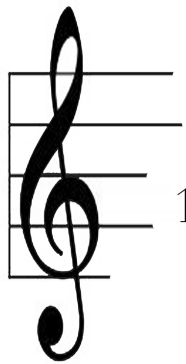

Dear Applicant:

We're pleased to tell you we determined you're exempt from federal income tax under Internal Revenue Code (IRC) Section 501(c)(3). Mr. Allen is a woodwind instrument designer and manufacturer. A few of the brand name instrument he designed, and manufactures are Kenny G Saxophones, Rheuben Allen Saxophone, Clarinets and accessories, Paris Master Model woodwinds, and more.

His client list as a woodwind repairman is among the best in the US. Tonight Show band with Jonny Carson woodwind players, Dan Higgins, Kenny G, David Koz, James Moody, Super Sax, Michael Brecker, John Klemmer, Clint Eastwood, Wilt Chamberlain, Phyllis Diller, Larry Hagman, Everett Harp, Macio Parker, Nestor Torres, Eddie Harris, Sam Most, Sam Riney, David Bowie, Ronnie Laws, Mike Paulo, Plas Johnson, Bobby Shew, Pete Christlieb, Dave Leibman, David Carradine, Lennie Niehaus, just to mention a few.
